HITLER AND OBAMA - 77 YEARS APART

On March 23, 1933, German Chancellor Adolph Hitler signed the National Law for Removing the Distress of the People bill. It was also called Hitler's Enabling Act. Did Ya Know?

Do you get chain letters from friends and neighbors that ask you to send a patriotic note or friendship letter on to at least 5 of your friends? I recently receive one talking about angels, loving your friends and praying for this or that. Here's a tip... never send chain letters to anyone and do not forward them to anyone. Why? Because the letters are used to get email addresses, nothing more. This is a way for criminals and con artists to get legitimate email addresses to use for spam messages in the future. So, **no matter how well meaning a chain letter is please do not send it to your friends.** *However, you can send them to Nancy Pelosi, Harry Reed and a few of their close allies! I'm sure they will be grateful to get these very sweet and kind notes!*

Out of work? Be careful on putting your resume out on the web. The great thing about posting your resume on the web is that everyone can see it. The bad thing is, of course, everyone can see it.. Including criminals. I applied for employment to a firm and for the next few months someone, in former communist Europe, used my return email address as the return address to sell Viagra and other sordid items. The unfortunate thing is that most on-line providers return bad email addresses to the name on the return of an email and not to the actual IP address. Which means I can place any address on an email and have it look like it came from that person but the number (IP address) is not used to return email. I received thousands of emails telling me that the note was not delivered and was identified as spam. Be careful out there as crooks are everywhere!

To give you an example, criminals are now praying on the unemployed by offering them jobs that are actually "mule schemes". These operations "hire" a job applicant to complete a trial project. The scam operators wire stolen money (from other people's credit cards) and place it onto the "hired" applicant's credit card. The person is then asked to purchase goods such as HD TVs or computers and send them to Eastern Europe where they are sold. Applicants end up with no job and no paycheck. Sometimes their remaining credit is ruined by collection agencies and credit card companies. It takes time to get it cleared up and at the worst time for the unemployed worker.

How are these scammers able to find people to con? Well, they use on line employment agencies such as Monster.com and CareerBuilder.com. While the on line career companies are on the up and up they have a difficult task in trying to keep criminals out of the systems and from praying on the unemployed.

What can you do to be watchful? First, if anyone wants to pay you to use your bank accounts that should be a great big red flag! Never give out any of your account information to anyone. So if anyone calls you and says they want to confirm your identity and asks you for your social security number or account number and password, never NEVER... give it to them. If they work for a company you do business with please have them give you the information and you confirm it. Never supply the information to them as that should have it already.

It's a bad world out there and even the most innocent note or letter can cause you pain. Please be very careful while on line and reading emails. ID theft is growing to be one of the biggest criminal growth areas and it doesn't look like it is going to drop off anytime soon.

Watch out for income tax scammers

Be wary of tax related scams as the deadline for submitting your federal income tax draws near. Some preparers without proper training deliberately mislead people as to their credibility.

Schemes, including identity theft and blatant fraud, are common. To avoid being scammed by a non legitimate tax preparer, consumers should request the credentials of tax preparers and ask if they belong to a state board or bar association that requires receiving continuing education. Ask if the business is open year round. Temporary employees or businesses should raise a red flag.

When choosing a tax preparer, ask about service fees and avoid those who claim they can obtain larger refunds than anyone else. Be very wary when taking out "Refund Anticipation Loans," as the fees will still be required even if the loan is not approved. The processing time for electronic filing is usually ten days and the refund is almost always directly deposited into the consumer's bank account at no cost. You should not feel pressured to pay extra fees to someone who claims they can get refunds faster. Ask whether the use of their refund anticipation loan for a few days would be worth fees that may equate up to 180 percent APR.

Shop around for quotes and ask the tax preparer if they will represent you if you are audited, or pay any audit related fees. Only attorneys, certified public accountants, and enrolled agents can represent taxpayers before the IRS in matters including audits, collections, and appeals. A common fraud associated with tax season is "phishing," which can occur when thieves posing as Internal Revenue Service Agents send e-mails seeking personal information allegedly for the purpose of processing refunds. The e-mails are usually created to look official and may include subject lines that read "Refund Notice" or other misleading phrases. The IRS does not send emails asking for personal information to process refunds.

You can visit the agency's Web site at www.IRS.gov and click on "Where's My Refund" to check on the status of your refund.

Another scheme during tax season is fraudulent charities who contact you seeking contributions they claim can be written off as tax deductible, and Social Security refund scams which are based on offers of social security tax refunds, even though no such refunds exist.

Never allow anyone purporting to be an agent for the IRS into your home unless he or she has proper identification. Do not give out personal identification information to anyone soliciting money. Don't respond to e-mails asking for information relating to refunds. The IRS Web site is the legitimate source for checking refund status. Consumers may file complaints about tax related scams or any other type of fraud by calling the Florida Attorney General's fraud hotline, 866-966-7226, or by filing a complaint online at www.myfloridalegal.com. They can also check company's complaint histories.
